AS A CUSTOMS RULE IN TURKEY, CONTAINER IS CONSIDERED AS A CARGO AND CUSTOMS CLEARANCE HAS TO BE DONE BY DEDICATED CUSTOMS BROKER OF LOCAL AGENT /OFFICE OF CARRIER. REGISTERED CONTAINER IS FOLLOWED UNTIL SHIPPED OUT OF TURKEY. EVERY LINE AGENT HAS TO ARRANGE THE FORMALITIES THROUGH A SPECIFIC CONTRACTED CUSTOMS BROKER.
